- 1) Consideration of Agenda
- 2) 50<sup>TH</sup> Anniversary
  - a. Coordinator's report (A. Roessler) – Royston Nash has been confirmed as the keynote speaker. We are also hoping to have him to speak at the Reunion Matinee performance on Sunday February 27. Because of the Reunion Brunch, the curtain for that Matinee will be delayed until 3 PM. Two applications for grants to fund the anniversary weekend have been submitted.
